# **<u>CRITERIA</u>:**

- All applicants are required to send photographs of their goods and booth/business at a similar event.
- Photographs that are mailed will not be returned.
- Applications must be submitted with photographs, all other required documentation, and payment in order to be considered.
- Applicants will be notified of acceptance no later than 6 weeks after the completed application has been received. If the application is denied, payment will be returned within one week of notification.
- Vendors provide their own tables, chairs, display unit, tent canopy.
- Spaces are 10' wide x 10' deep both on the festival streets and grass in Union Point Park.
- Vendors are required to stay open <u>all</u> hours of the festival.
- All merchandise must be visibly priced. Distribution of literature or samples must be related to exhibit.
- Giveaways, raffles, drawings and contests **MUST** be pre-approved.
- BEVERAGES, INCLUDING BOTTLED WATER AND FOOD PRODUCTS CANNOT BE SOLD OR GIVEN AWAY FROM THE VENDOR'S SPACE. <u>NO EXCEPTIONS</u>.
- Fee is refundable (less \$50 processing fee) if written cancellation notice is received by 7/1/2016. Email is an acceptable form of communication.
- Vendors must have a NC Sales Tax Number which can be purchased from the NC State Revenue office.
- The State of North Carolina requires Workers Comp insurance if you have 3 or more employees. Proof of that insurance is required. If it is applicable to your organization.
- ALL work must be handmade and the original design of the exhibitor. No exceptions.

#### **IMPORTANT—MumFest Commercial Application is Required when:**

Items made from kits, models, molds, or are massed produced, imported, machine made, live plants or commercial items embellished by the applicant for resale, CD's, foodstuff (prepackaged jams, jellies, condiments), t-shirts and the combined sale of handmade and commercial items in the same space, <u>all require a MumFest Vendor Commercial application</u>. MumFest has the final say if items submitted qualify for the <u>Arts & Crafts</u> or <u>Commercial</u> category. Your concession cannot encroach on vendors in adjacent spaces. <u>THERE IS NO SPACE</u> <u>BETWEEN CONCESSIONS</u> so measure carefully and thoroughly! In determining the exact footage needed for your concession, be sure to include trailer tongues, canopies, counters, etc. <u>You will not be allowed to set up if your concession extends beyond</u> <u>your assigned space</u>.

# **ADDITIONAL INFORMATION:**

- Overnight security is provided Friday & Saturday evenings and early mornings.
- Vendors will be charged a **\$30.00 processing fee** for checks returned for insufficient funds.
- Email address is required.
- All correspondence will be communicated electronically.
- Space assignments, parking information, etc. will be emailed to vendors in late September 2016.

The undersigned agrees that they will be responsible for any loss or damage to their work/display area during MumFest '16 and Swiss Bear Downtown Development Corporation and the City of New Bern will be held harmless in the event of an incident. (It is recommended that all MumFest '16 vendors have general liability insurance in the event of a loss.) It is further agreed that the undersigned will abide by all rules and instructions set forth in this application. Violators maybe subject to dismissal. No refunds after July 1, 2016.
